- original copy of the payment due of the amount due, and slip currency exchange for foreign Companies

The technical and financial offers are inserted in two envelopes separate, anonymous and closed, indicating on the outside of each, respectively the mentions "Technical offer - do not open - invitation to tender National and International Open - N° 135/2021/TA6 - the purpose of the tender" and "Financial offer - do not open - invitation to tender National and International Open - N° 135/2021/TA6 - the purpose of the tender"
