The technical and financial tenders shall be inserted in two separate, anonymous and closed envelopes, indicating on the outside of each respectively, and the words Technical tender-Not to be opened-National tender – not to be opened-National Invitation to tender and International Open – n. *316*./2021/CG1- objet of invitation to tender" and financial offer-Not to be opened National Invitation to Tender and International Open- N. *316*./2021/CG1- objet of invitation to tender".
