The Ministry of National Defence launches open national and international tender offers to Online acquisition of satellite Night-Time Light (NTL) imagery and derived products. Companies interested in this tender notice can present their delegates at the address below:

for the withdrawal of the specifications document, against payment of the sum of Ten Thousand Algerian Dinars (10.000,00 AD) for companies incorporated under Algerian law and the equivalent in foreign currency, for foreign companies, to the account number 201.007.07.10 entitled "various products of state budget", opened at the Central Treasury of Algiers (RIB: 008970011299997001 -65, Swift/BIC: BALGDZAL, RTGS: 9713000000).

The delegates for withdrawal of the specifications document must provide:

- One (01) copy of a valid identity document;
- One (01) copy of an accreditation letter issued by the candidate for submission;
- One (01) copy of the trade register electronic of the company;
- The original copy of the payment receipt for the amount due, and slip currency exchange, for the foreign companies.

The offers including pieces and documents required in the specifications document should be split in three (03) parts:

- One (01) of the candidature file containing document required by the specifications document;
- One (01) of the technical offer including the documents required by the specifications document;
- One (01) of the financial business offer including the documents required by the specifications document.

The candidature file is put into anonymous envelope separated from those of the technical and financial offers, containing on the exterior the mention:
