The technical and financial tenders shall be inserted in two separate, anonymous and closed envelopes, indicating on the outside of each respectively, and the words **Technical tender-Not to be opened-National tender – not to be opened-National Invitation to tender and International Open No. **366**/2024/CG1, object of Invitation to Tenders"** and financial offer-Not to be opened National Invitation to Tender and International Open- No. **366**/2024/CG1, object of Invitation to Tenders".

The envelopes containing the candidate file, the technical and financial offers, must be sent in a sealed envelope to the following address:
