For the withdrawal of the schedule of conditions, against payment of the sum of **Five Thousand Algerian Dinars « 5.000,00 AD » for companies incorporated under Algerian law and the equivalent in foreign currency, for foreign companies** to account N°201.007.07.10 (RIB 00897001199997001-65) SWIFT RTGS 9740010000, entitled Direction of Financial Services / MND opened at the **Central Treasury of Algiers**.

The delegates for the withdrawal of the schedule of conditions must be provided:

- a copy of an identity piece valid
- an accreditation letter issued by the candidate for submission ;
- a copy of the trade register of the company ;
- the original copy of the purchase payment amount due, and slip currency exchange, for the foreign firms ;

The offers including pieces and documents required in the schedule of conditions should be split in three (03) parts:

- 1- One candidature file containing document required in the specification
- 2- a technical offer including the documents required by the schedule of conditions;
- 3- a financial business offer including the documents required by specification
