The people delegated to the withdrawal of the specifications must bring the following documents:

- One (01) letter of accreditation issued by the candidate of the submission;

« **Financial offer –Do not open - Open National and International Tender n° <sup>019</sup>...../2026/SC1** » object of the tenders.
