To take out the tender, against payment of equivalent of the sum of five thousand Dinars of Algeria (5.000,00 DA) for the companies of Algerian right and the equivalent in currency, for the foreign companies, with the account n°201.007.07.10 (RIB 008970011299997001-65), open near the Central Treasury of Algiers, and slip currency exchange SWIFT/BIC RTGS 9713000000 of the Bank of Algeria for foreign Companies.

The persons delegated to take out the tender must be provided of :

- a copy of validated identity pieces;
 - a letter of accreditation delivered by the sub missioners;
 - a copy of the register of trade with quick reponse code of the company;
 - original copy of the payment due of the amount due, and slip currency exchange for foreign Companies
