- a copy of the trade register of the company ;
- the original copy of the purchase payment amount due, and slip currency exchange, for the foreign firms ;

The offers including pieces and documents required in the schedule of conditions should be split in three (03) parts:

- 1- One (01) candidature file containing document required in the specification
- 2- A technical offer including the documents required by the schedule of conditions;
- 3-a financial business offer including the documents required by specification
